

GENERAL TERMS AND CONDITIONS

1.-Application

The general terms and conditions described hereinafter are in force as of March 1st, 2018 and will be applied until October 5th, 2018 by the organizers of the Conference “Adaptive Management of Forested Landscapes in Transformation”, event that will take place in the city of Posadas from October 1st to October 5th, 2018. The general terms and conditions apply in relation to conferences, exhibitions, symposiums, workshops, field trips, as well as the rest of services and additional goods provided by the organizers in relation to the said events.

The acceptance of these terms and conditions assumes acceptance in your name and that of all the people in whose name you make the registration.

2.-Place of celebration of the event.

The event will take place in Calle Ulises López y RN12 (Acceso Oeste), Posadas, Misiones, Argentina.

3.-Contract

The registration contract will be completed after receiving the corresponding payment, for the indicated amount. By making the registration you accept these general terms and conditions. The person who makes the registration is fully and exclusively responsible for the accuracy of all the information stated. It is essential that you review the data of the registration made and inform us immediately of any errors.

4.-Registration and Confirmation

All bookings are legally binding. Congress participation and all congress event bookings will be confirmed in writing by the Organizers. Registration is binding upon receipt of the registration simultaneously with the direct debit mandate for the amount due. Only upon request by the registrant will an invoice be sent per post.

5.-Prices, Payment

All prices are in US dollars (for foreigners) and in \$ Argentinean Pesos (for Argentinean nationals). Any bank charges arising from return debit notes will be credited to the registrants account.

When the payment has been successfully processed, the registered person will receive a confirmation by e-mail.

6.-Cancellations, Changes

All notifications of changes or cancellations, all or in part, are required in writing. Cancellations received until 20 days before the beginning of the Conference will be refunded previous 30% discount of the total amount. The transfer expense shall also be discounted from the registration fee. After September 10th, neither the registration fee nor fees for other congress events will be refunded. The registrant who cannot attend the congress, has the option of sending a substitute which must be informed by writing to the organization. An unsuccessful visa application is no reason for a refund. Refunds will be processed after the Conference. No reimbursement will be made for the cancellation of the Conference’s Dinner at any time.

7.-Event Cancellations

An event or particular element of the congress (e.g. training courses) can only be carried out if a certain minimum number of participants is reached. If this minimum number is not reached, the organizer reserves the right to cancel the event or individual elements at short notice. In such a case, the already paid fee will be fully refunded.

The cancellation of any of the speakers for reasons beyond the control of the organization will not entitle the refund of the fee paid, as it is not an essential condition of a Conference's offer the appearance of a speaker or specific author, but the existence of a varied number of activities, conferences and workshops that will make up the overall program of the Congress. However, the organization will make its best efforts to avoid that such cancellation may create an inconvenience to those attending the Congress, such as, among others, reorganizing the schedule or replacing the author or speaker canceled by another speaker or author.

However, the organizer will not be responsible for other costs or losses in which the participant may incur, such as transportation or accommodation expenses, etc.

8.-Force Majeure, Disclaimer

The organization reserves the right to introduce a change in the program related to reasons such as the impossibility of attending the speakers or causes of force majeure, which will not entitle the claim for refund of the (proportionate) registration fees or for a compensation of any (financial) losses incurred.

In case the event cannot be organized or is subject to change due to reasons which are outside of the sphere of responsibility of the organizer (e.g. natural catastrophe, strike or force majeure), no claim for refund of the (proportionate) registration fees or for a compensation of any (financial) losses can be made.

9.-Registration and Information during the Congress

During the Congress, there will be a counter for the distribution of the accreditations as well as to answer any questions to the participants.

10.-Corporate Veil

Please be advised that the organizer is only liable for claims arising from physical injuries due to intent or negligence of the organizer, or for claims arising from property damages due to intent or gross negligence of the organizer. Any further claims are excluded. The organizer is not responsible for the loss or theft of objects, including personal property, or motorized vehicles, except in cases of intent or gross negligence on their part. This shall not affect further claims against persons and/or companies charged with the excursions/events related to the congress.

11.-Applicable Law, Place of Performance and Jurisdiction

The laws of the Federal Republic of Argentina apply. To the extent permitted by law, Posadas, Misiones is the place of performance and jurisdiction for all claims.

12.-Use of Photos, Image Rights

All congress participants are herewith informed that photos, videos and audio recording of the attendees will be made during the congress and all accompanying congress events. This

material will be published in the internet, professional journals and/or other publications during and after the congress. The participants agree to the usage or release of these recordings by confirming the general terms and conditions.
